# Increased capacity and margins

#### **Accelerating document turnaround time**


Reduce drafting time from hours to minutes.

#### **Speeding up turnaround times**

## Supporting hybrid working

In recent years, the workplace has changed beyond all recognition and a full-time return to the office is looking increasingly unlikely. Lockdowns showed us there's more to supporting remote working than using Microsoft Teams and DocuSign. So, with more lawyers, including those in real estate, opting for the flexibility of partial remote working, law firms are turning to technology, such as document automation, to create resilient ways to enable teamworking across multiple locations.
